The Presidium in its entirety is responsible to the Congress for the finances of IUSY. The financial report has to be discussed by the World Congress and World Council. The sources of finance are membership fees; incomes from activities and publications; *personal donations*, inheritance and other allocations; and grants from national, regional and international institutions. *IUSY can take donations from non-profit companies, but not from profit-making companies.* The finances of IUSY must be presented to a qualified external auditor on an annual basis.

Explanation:

Donations from companies, banks or other profit oriented organisations should be avoided so as to ensure neutrality.
