1	During the past ten years has an increase of terrorist attacks in the world occurred. This
2	development has also increased the activity and acts surrounding terrorist attacks, such
3	as training and traveling to join terror organizations. Therefore, it is crucial to create
4	sustainable anti-terror legislations to help prevent and effectively contribute to the larger
5	goal of fighting international terrorism, which can be made more efficient by
6	criminalizing the whole cycle of terrorism.
7	This proposal mends the gap between financing and actively participating, it expands
8	the area of criminalization of terrorism by including more features on what can be
9	viewed as a terrorist act.
10	The terrorist act does not have to be narrowed down to the sense that an attack has
11	been completed. Terrorism are already committed when entering or traveling to fight for
12	the cause.
13	This would include the whole cycle of a terrorist attack, from funding to aiding and
14	abetting, recruitment or training as well as the attempt to commission these offenses.
15	With this notion, the responsibility and prosecution of terrorist acts would be easier and

16 more efficient regardless if a terrorist attack or war crime has been attempted or
17 conducted.

18 There has been action taken such as the criminalization of traveling to join and fight for
19 terrorist organizations. Also, financing terrorist organizations is criminalized in some
20 countries. But we see the matter of collaboration and active participating equally harmful
21 as financing and therefore it should be criminalized. This type of legalization makes a
22 complement to already existing laws and makes it easier to convict terrorists.

23 Therefore, IUSY argues that:

- 24 - Association and cooperation with terror organizations should be criminalized
- 25 - It should be illegal to finance or participate in terrorist organization
