Today, as we face new forms of oligarchy, the rise of extractive capital, growing inequalities, and a deepening intergenerational divide, closer collaboration between socialist youth across borders is not optional — it is essential. Without abandoning our national identities, we must work together toward common answers to shared global problems.

If elected, I commit to working for the elevation of youth issues as a political priority on every front, the strengthening of Southern and Balkan youth voices within IUSY and the connection of socialist youth with movements of labor, trade unions, civil society, and local communities.
