IUSY unequivocally denounce the systemic and unlawful imprisonment of Palestinians by the fascist Israeli occupation. Under international law, individuals detained by an occupying power outside the framework of fair and regular judicial processes — particularly through collective punishment or political targeting — must be recognized as hostages, not lawful detainees. The thousands of Palestinians held in Israeli prisons are considered by the Israeli regime as prisoners, forcibly taken to violate their right to resist colonialism and their right to existence. Within this context, Palestinians are also internationally acknowledged as political hostages, imprisoned solely for their struggle for freedom, dignity, and self-determination.

As of 2025, nearly 10,000 Palestinian hostages are held in Israeli prisons, including hundreds of children, women and elderly. Hostages are being imprisoned without charge or trial under so-called administrative detention by Israeli regime. These are not legal or judicial procedures — they are political abductions enforced by military occupation courts that boast a conviction rate of over 99%. Such courts exist not to deliver justice but to criminalize the very existence and struggle of Palestinians. These are measurements of apartheid, colonial oppression, and statesanctioned terror, completely lacking any legitimacy under international standards.

Inside these brutal prisons, Palestinians are subjected to systematic torture, rape, enforced disappearance, and sexual violence. UN bodies and human rights organizations have meticulously documented Israel's use of physical and psychological torture: beatings, sexual assault, stress positions, prolonged isolation, denial of urgent medical care, and other forms of inhumane conditions — even against minors and civilians seized during military raids. These are not random abuses; they are the foundation of a violent colonial prison system built to crush the spirit of an entire population.

Administrative detention — imprisonment without charge, evidence, or trial — is a blatant violation of international humanitarian law, including the Fourth Geneva Convention and the International Covenant on Civil and Political Rights.

These mass imprisonments occur in the broader framework of violent occupation, apartheid, and systemic racial discrimination. Palestinian detainees are not criminals — they are hostages of a fascist regime that seeks to erase dignity and humanity under the guise of law. Israel's use of incarceration, military law, and mass abductions, as a justification for security, however, are solely excuses for domination, erasure, and colonial violence.

Therefore, IUSY:

- Condemns the entire system of Israeli imprisonment of Palestinians as unlawful, political and forms of apartheid.
- Demands the immediate release of all Palestinian hostages especially women, children, the sick, and the elderly, at the same time the abolishment of the colonial military court system.
- Demands an end to torture, rape, full isolation, and the denial of medical care practices, which constitutes war crimes and crimes against humanity.
- Supports full international accountability mechanisms, including investigations and prosecutions by the ICC and ICJ, and the establishment of a UN-led inquiry into Israel's treatment of Palestinian hostages.
- Demands accountability, sanctions and legal action against Israeli officials, military commanders, and prison personnel involved in torture, sexual violence, and arbitrary imprisonment.
- Calls upon the international community to take responsibility and tangible actions to hold the Israeli apartheid regime accountable.
