1.Dear member organizations,

2.Lebanon today stands at the edge of a dangerous confrontation, facing not only an escalating
3.war with Israel on our southern border, but also the long-term consequences of decades of
4.unresolved conflict, international double standards, and regional instability. Lebanon is a nation
5.under pressure, politically paralyzed, economically strangled, and militarily violated. Our
6.economy is in freefall. The Lebanese pound has collapsed. Basic services—electricity, water,
7.healthcare—have become luxuries for many. And amid all this suffering, we continue to face
8.daily violations of our sovereignty by Israel—violations that the world too often turns a blind eye
9.to.

10.From the skies over Beirut to the hills of the South, Lebanon’s dignity is being trampled by a
11.foreign power that continues to occupy our land and challenge our right to exist in peace. UN
12.Resolution 1701 was supposed to end the hostilities, secure our borders, and protect our
13.people. Yet to this day, Israel refuses to comply. It remains in violation of international law—and
14.Lebanon pays the price.

15.The Progressive Youth Organization demands the immediate and full implementation of United
16.Nations Security Council Resolution 1701 in all its provisions without exception; Calls upon the
17.international community, including the United Nations and its Security Council, to exert all
18.necessary pressure to ensure Israel’s full compliance with international law and UN resolutions,
19.particularly regarding the cessation of hostilities and the respect for the Blue Line; Urges the
20.Government of Israel to cease all violations of Lebanese sovereignty, including air and ground
21.incursions, and to immediately withdraw from all Lebanese territory, particularly the northern
22.part of Ghajar and other areas still under occupation; Expresses support for the role of the

23. United Nations Interim Force in Lebanon (UNIFIL) and the Lebanese Armed Forces in
24. preserving peace and stability in southern Lebanon and calls for their continued coordination in
25. upholding Resolution 1701; Affirms the right of the Lebanese people to live in peace and
26. security within their internationally recognized borders, free from occupation, aggression, or
27. threats to their sovereignty; Requests that the United Nations Secretary-General provide
28. regular updates on the status of implementation of Resolution 1701 and report all violations
29. committed by either party, particularly those undermining Lebanon's security and territorial
30. integrity; Stresses that lasting peace and stability in the region can only be achieved through
31. mutual respect, adherence to international law, and the resolution of all pending issues,
32. including the Israeli occupation of remaining Lebanese territories, and disbandment of all
33. Lebanese and non-Lebanese militias and the unification of all armed forces under the authority
34. of the state.

35. This is not just a political issue; it is a national duty! It is time for the international community to
36. step up and enforce the very resolutions it has passed. It is time to say, clearly and firmly:
37. Lebanon is not a playground for regional aggression. Lebanon is a sovereign nation, and we
38. will not accept anything less than full respect for our rights, our territory, and our future.
