TITLE/ TÍTULO/ TITRE:	Illegal and Non-Protocol Aspects of the Meeting Between the President of the Norwegian Parliament and the Son of the Deposed Iranian Shah

This resolution notes with concern that:

- The display of an unofficial or unrecognized flag alongside Norway's national flag on official parliamentary premises constitutes a breach of diplomatic protocol and Norwegian governmental procedures;
- Under international diplomatic practice, flags displayed in official governmental settings carry significant political and legal meaning, implying recognition or endorsement;
- The Norwegian Parliament's President, as a representative of the legislative branch, lacks the authority to unilaterally alter Norway's diplomatic recognition policies, which remain the purview of the executive branch and foreign ministry;
- The meeting, in its format and presentation, created ambiguity regarding Norway's official position on Iran's political opposition movements and historical monarchy;
- The use of parliamentary facilities and symbols for meetings that could be interpreted as endorsing new fascism in Iran

Therefore, this resolution:

- Declares that the meeting between the President of the Norwegian Parliament and the son of the deposed Shah of Iran, particularly regarding the flag display, constituted a breach of diplomatic protocol and exceeded appropriate parliamentary authority;
- Calls for the establishment of clearer guidelines regarding meetings between parliamentary officials and foreign political figures who do not hold official governmental positions
- Recommends the development of explicit protocols governing the display of flags and other national symbols in parliamentary settings;
- Urges parliamentary leadership to consult with the Ministry of Foreign Affairs before engaging in meetings that could impact Norway's international position or be interpreted as shifts in diplomatic recognition;
- Emphasizes the importance of maintaining clear distinctions between personal political views and official parliamentary functions;
- Requests a review of existing parliamentary procedures to prevent similar protocol breaches in the future;
